Dear TIMS member,

TIMS's Symposia are back!

The 16th Symposium of TIMS will take place September 21st to 26th , 2024.

Once again, I have the honour of serving the Society by chairing a symposium. Difficult times make it harder to deliver, but we (our team and Etnoideia) are fully committed and working hard to make it a success for TIMS and memorable for you!

We want to share with you the programme we are organizing. It is very close to its final form: dates, places and resources have already been set and will not be changed, so everybody can prepare travel arrangements. Yet nowadays, one can never put aside some unpredictability, so minor changes may have to occur. A final programme will be issued by July 31st, 2024.

The Municipalities of Ponte de Sor (near Lisbon) and Valongo (near Porto) will host the symposium. The symposium will be held during 6 days in these two locations, with a 2-day Mid-Tour (*Central Portugal Mills*) heading north and offering participants a comprehensive perspective of the diversity of Portuguese mills. Many Municipalities across the country will be collaborating and receiving TIMS members in their areas during the visits. Etnoideia will manage the event, providing a team and taking corporate responsibility under Portuguese law, thus complying to all legal requirements with respect to such an event.

Following the tradition of TIMS symposia, there will be a Pre- and a Post-Symposium tour, depending on a minimum of participants. The Pre-Tour will visit Southern Portugal, Tagus Estuary and Western Coast mills and the Post-Tour will visit mills in Northern Portugal.

There will be no pre-defined mandatory theme for papers in order to allow for the great diversity of TIMS and molinology to emerge. If any, the symposium's signature will derive from the thematic nature of member paper submissions. However, the framework of "Mills and Sustainability in the 21st Century" is proposed as a preliminary theme!

PROGRAMME - SYMPOSIUM

The Symposium will take place at two venues, in cities chosen by both the significance of their molinological heritage and the quality of local action in effective mill preservation.

There will be a lot of opportunities to present and discuss, as the programme contains 11 paper sessions, with 18 hours available for presentations and discussions.

The traditional book selling space will also be available for everyone to sell, acquire, and exchange mill books.


September 20th Arrivals and check-in all day long

September 21st, 22nd Ponte de Sor (100 km NE Lisbon)

The Opening Session and first two days of paper sessions will be held in Ponte de Sor, where the Municipality preserved the "Fábrica de Moagem de Cereais e Descasque de Arroz" an 1920 grinding and rice dehusking mill. This is now a cultural centre with a fine conference room for 150 people, and will be the first symposium venue. The windmill of Foros de Arrão was also reconstructed with a wooden oven for traditional bread making demonstrations. Other water mills are on the way to be preserved too. Currently, they are finishing the construction of a considerably large interpretive centre of Molinology and Alentejo mills. These mills will be visited during our stay in Ponte de Sor.

September 23rd, 24th Symposium Mid-Tour to Central Portugal Mills

The Symposium Mid-Tour will take two days, heading west from Ponte de Sor then North until Condeixa-a-Nova. From this location, the tour will explore inner mountain landscape and mills. On the second day, the tour heads west again to follow the Atlantic coast until it reaches Greater Porto and finally Valongo.

Types of mills to be visited:

- Watermills
 - Horizontal open wheel
 - Horizontal enclosed wheel
 - Submersible with horizontal wheel
 - Vertical overshot wheel
 - Olive oil mill, vertical overshot wheel and wooden beams press
 - Hybrid: horizontal undershot wheel + horizontal wheels
 - Horizontal open wheel corn grinding and rice dehusking with corked mill stones

• Windmills

- Stone tower mill with internal capstan and cloth sails
- Wooden tower mill with internal capstan and cloth sails
- American mill
- Cave mill unique "Abiúl type"
- Wooden paltrock
- Stone tower mill with tale pole and cloth Latin sails
- Animal Powered
 - Donkey & cow linen mill with ground spur wheel

During the Symposium and Mid-Tour to Central Portugal Mills, there will be a lot of travelling by BUS, approximately 700 Km with many quick stops to mill visits.




September 25th, 26th Valongo (5 km NE Porto)

The venue for the remaining paper sessions, closure and the TIMS General Meeting will be in Valongo: a historically important region of bread making in Porto from the 18th to the 20th century featuring a significant concentration of bakers, mills, and the birthplace of a distinctive fine bread known as "Regueifa". This type of bread is an icon of Porto's culture, comparable to the importance of Port wine for the locals.

The city has established an important recovery centre called "Oficina da Regueifa" that focuses on the past, present and future, bringing new techniques for traditional bread making to the modern world.

Furthermore, a central place is offered to mills as the municipality has set up a comprehensive programme for the preservation of all types of mills in the area: i.e. windmills (rare in this region), undershot watermills hybrid with horizontal wheeled mills, small horizontal wheeled mills, etc. Some of these mills will be visited during our stay in Valongo.

PROGRAMME PRE-SYMPOSIUM TOUR

Southern Portugal, Tagus Estuary and Western Coast mills

September 19th, 20th 2024

This two-day tour will start September 19th early morning, so please consider booking hotel accommodation in Lisbon for the night of 18th September. Participants will be informed of a meeting point where to take the BUS.

On the first day, the tour will explore the Tagus Estuary and start by visiting one of the 18th century windmills of the 500 that existed in Lisbon at Tagus north bank. From there, the tour will visit several of the Mills of Oeste with a lunch and reception in the Regional Government Office in Caldas da Rainha. The Region has recently approved an integrated strategy for the preservation and future of more than 900 windmills in 12 municipalities, hosted a Portuguese Mills Network Conference last year and created a common chart for the preservation of windmills and is arranging funds to help mill owners preserving their mills.

On the second day, the tour will head south to visit the Tagus south bank with windmills and tide mills in Seixal, Montijo and Barreiro. Then, further south to windmills at Santiago do Cacém, Odemira and Castro Verde. Finally, northeast to Évora windmill (the medieval historic city classified by UNESCO and World Heritage) and then Ponte de Sor to arrive late in the afternoon.

Please note that the organization of this tour is yet to be decided, as it may not be cost-effective if only a small group of members apply. Transportation costs are common and will be divided by the number of seats occupied. Applicants will also be asked if they would be willing to drive rental vans should that turn out to be significantly more cost-effective, but it all depends on the group's size. So, until November 30th, you will only be asked to tell us if you want to participate. We will then consider the group's size and decide whether or not to proceed with the tour.

PROGRAMME POST-SYMPOSIUM TOUR

Northern Portugal mills

September 27th, 28th 2024

This two-day tour will end on the 28th late afternoon, so please consider booking hotel accommodation in Lisbon or Porto for the night of 28th September. The BUS will drop participants in a previously informed point (or if possible at their hotels) in either of the two cities, depending on their onward plans.

The tour will start September 27th early morning in Valongo and explore the northern provinces of Minho and Trás-os-Montes. From Valongo the tour will head east to Fafe to visit the Windmill



and mill museum of Aboim and two cow mills: a primitive tanning mill and a linen mill. Then the tour will travel to the other side of the mountain to reach the remote area of Barroso in Boticas where TIMS 2004 Symposium took place. Several horizontal watermills will be visited, the Mill of Porto and communal oven of the Historic Village of Vilarinho Seco. A rare Arubah type watermill will also be visited in a remote area of the mountain.

On the second day, the tour will head west to Lousada to visit Pias Mill Park, a thematic park of watermills near Porto. From there, further west to Barcelos to look at the exterior of a river watermill with undershot wheel at the base of a medieval bridge. Then to the coast until Esposende to visit the recently reconstructed windmills and watermill (exteriors) at the Mill Park of Abelheira. From there the tour heads north to Viana do Castelo to visit Montedor wooden sails windmill (rare in Portugal) and the old tidal mill "Azenhas de D. Prior". Then south to Gaia, southern side of the Douro, to visit a watermill in the Gaia BioPark. Finally, the tour heads to Porto drop point and then to Lisbon

Please note that the organization of this tour is yet to be decided, as it may not be cost-effective if only a small group of members apply. Transportation costs are common and will be divided by the number of seats occupied. Applicants will also be asked if they would be willing to drive rental vans should that turn out to be significantly more cost-effective, but it all depends on the group's size. So, until November 30th, you will only be asked to tell us if you want to participate. We will then consider the group's size and decide whether or not to proceed with the tour.

PARTICIPATION FEES

Please note that fees have been calculated for a Portuguese inflation rate forecast of 4% in 2024. It is not expected to exceed this rate, but if such a situation occurs, the organization may have to charge the surplus to applicants.

TRAVEL ARRANGEMENTS

You will be asked to send details of your travel arrangements. For the time being we just need a prevision. If you do not have final information to give us you can send the final dates and flight details until 30th April 2024 at the latest. However, please make your prevision as accurate as possible so we can work properly in organizing logistics.

ARRIVALS

You should arrive at Lisbon Airport September 20th 2024

On September 20th there will be two pickup Buses at Lisbon Airport (14H00 and 18H00, although these schedules may vary to match everybody's flights. Anyone, flying in or not, may get these buses.

Should you miss them, you will be on your own to catch one of the pickup buses at Lisbon Airport or to get to Ponte de Sor by other means or public transportation.

If you plan to travel by car and to get to Ponte de Sor on your own, please inform the organization.

DEPARTURES

You may depart from Lisbon Airport or Porto Airport.

On September 27th an early BUS will take members to Porto Airport and continue to Lisbon Airport. Participants will be informed about BUS departure time)



ACCOMMODATION

Accommodation is included in the Symposium Fee and the organization will book it for you on the nights of 20th, 21st, 22nd, 23rd, 24th, 25th and 26th September.

If you wish to book hotels before or after these dates in Lisbon or Porto and need assistance, we may help you on the process but you should then pay directly to the Hotels.

All members will stay in double rooms with Air Conditioning, TV, Wireless, and Private WC and two single beds or one large bed if demanded and available in hotels. Whenever possible all members will stay in the same or nearby hotels, although in some cases accommodation options are limited. The organization will seek for the best solutions available according to the number of participants and hotels available. Members will be asked to name their roommates in the application form.

Standard hotels will be ***, but this may have to vary in some cases to **or ****or AL (B&B) depending on availability.

MEALS

All meals are included in the fee.

Everyday meals will be breakfast (hotel), morning and afternoon coffee breaks (at the venue), lunch and dinner.

Members will be asked to indicate their special dietary requirements, if any. Vegetarian, health, allergy or religious mandatory impeachments will be taken into account, but the organization may not be able to meet all requirements at all times. Especially during mill visits.

This is to be evaluated by the organization and confirmed on a case by case basis.

INSURANCE AND HEALTH CARE

Symposium participants will be covered by accident insurance during mill visits, conference activities and BUS transportation. Hotels, of course, have insurance for guests while in residence. Anyway, bad luck may happen to anyone, so please ensure you have personal travel insurance for accidents and health care.

EU citizens may apply for public health care in Portugal, other country nationals are strongly advised to make health traveler insurance.

Please note that participants must take full responsibility for all health costs and or any other not covered by the standard symposium insurance.



CALL FOR PAPERS

Submissions of Papers and Informal Presentations will be accepted until November 30th, 2023. At this stage, applicants must submit title, subject and abstract, as well as the venue resources needed (video projector, software requirements – only Microsoft software will be available).

Deadline April 30th, 2024

- Final format paper submissions for presentations with:
 - A personal photo (passport format) from the author is mandatory for publication (except individual objection)
 - An abstract is mandatory: 750 to 1000 characters i.e. 1/3 A4 page.
- o Final format Informal presentation submissions

Any TIMS member may present a formal paper or an informal short contribution.

There will be no pre-defined mandatory theme for papers in order to allow for the great diversity of TIMS and molinology to emerge. If any, the symposium's signature will derive from the thematic nature of member paper submissions. However, the framework of "Mills and Sustainability in the 21st Century" is proposed as a preliminary theme!

All papers that may have been prepared for Poland should fit perfectly to the Symposium requirements, therefore TIMS24 adopts formatting requirements and contents suggestions issued by former Symposium Chairman Paweł Roszak-Kwiatek and the Polish organizing committee to whom we thank and salute.

Papers are expected to address mill protection, renovation, giving them new functions, law adjustments, promotion of mills, the functionality of mills in the modern world, and the way of saving them for future generations.

Formal papers

The symposium participants will receive the papers in advance and are expected to have read them; therefore, authors will receive only 20 minutes for presenting a summary of their paper and 10 minutes for engaging in discussion with the audience.

Informal contributions

We expect in advance detailed information (paper or presentation file) on the subject. The time required to present the informal paper: maximum of 20 minutes including discussion.

Please note that informal contributions will not be published in the Transactions.

All contributions must be in the English language.



The Organization will decide on the acceptance of submitted papers and informal contributions, and its decision will be final.

All papers will be published after the symposium in the TIMS transactions. (Up: extracted from previous Poland Call for Papers)

Formatting Papers

The Symposium adopts IM guidelines for authors published on the TIMS website www.molinology.org

Quality

- Publications should reflect a good academic standard. Preferably, papers should reflect original presentations based on fine research.
- Wherever possible, selected photographs, drawings and tables should be included to enhance the associated text and aid in its understanding. The illustrations must be of good publishable quality.
- Whenever approval of third parties for using information is applicable, the author should ensure such permission has been granted.
- If deemed necessary by providers of information, their consent should be properly mentioned.
- All papers must be compliant with EU data protection regulations, so a signed authorizing declaration should be issued if personal data is to be published.

House style

Papers will only be published in English, the official language of TIMS. The editor and fellow members of TIMS will always assist with translation wherever possible.

Units should all be in metric/S.I. unless there is a requirement to maintain historical integrity.

Articles

- Title page should contain the title, sub-title (if any), and the author's full name. Also, postal and e-mail address should be provided at the end of the article.
- Tables & Illustrations should both be numbered in Arabic numerals. Tables require a heading and illustrations a caption.
- References should be placed at the end of the article and identified in the text by Arabic numerals in square brackets or in superscript. The information supplied in a reference should be:
 - for an article, provide the author(s) name(s), article title, publication title, volume (& part) number, publication date, and page numbers in the publication.
 - for a book, provide the author(s) name(s), book title, and publication date (optionally, also the page numbers).
- If the author wishes references to be in their home language they must also supply an English translation, and both will then be published.

Illustrations

- Do not copy paste power point slides to a word file, quality will be unpublishable.
- Do not embed any illustrations or tables in a word processing file, especially in MS Word files. The preferable placement of the illustrations and tables can be indicated in the text file.
- Illustrations should be sent separately by email or, if there are a number, by "WeTransfer" (www.wetransfer.com) to timsportugal2024@etnoideia.pt
- Illustrations will ideally be supplied as a colour digital image either from a digital camera or from a scanner:
 - Digital photographs should be the maximum image size of the camera and use the 'best' or 'fine' quality settings.
 - Scans should have a resolution of at least 300 dpi and should be provided as a .jpg file with the lowest available degree of compression.
